****The following policies apply to the EQUUSOMA® Practical Intensives and the RD Master Class****

Additional information and policies are outlined in the EQUUSOMA® Policy Handbook. Certain policies will also apply to the RD Master Class at the discretion of the Schlote Psychotherapy Professional Corporation (Sarah Schlote) and Calming Signals of Horses (Rachael Draaisma). These two companies and their agents and representatives are not liable or responsible for any lost wages or fees (including but not limited to travel and accommodation) incurred as a result of having to reserve time to support any of our events or activities should they be cancelled. We apologize for any inconvenience and appreciate your understanding when circumstances are beyond our control.

***Attendance at the RD Master Class in-person seminar requires having completed the 3-day online webinar first. However, if you can't attend the webinar live, this requirement can be met by watching the recordings prior to attending the seminar.*

RD Master Class Online Webinar

Student Cancellations

Students are eligible for a **100% refund** if cancelling more than 90 days before the first day of the online webinar, and a **50% refund** if cancelling between 60-89 days before the first day of the webinar. A \$100 CAD administrative fee is applied to process refunds. No refunds are possible for cancellations that occur in the 59 days before the first day of the webinar.

Instructor Cancellations

On occasion, an online webinar may be affected by reasons beyond our control, such as due to instructor illness or emergency, or a technical issue (e.g., an internet, power, or Zoom service outage). In these cases, we may need to adjust some or all of the dates of a particular webinar. The revised dates may not work with a particular student's availability. Depending on when the module was affected (before or after it began), **the following options are possible:**

1. If the student is unable to attend the revised dates live but is willing to watch the recordings, no refund will be provided.
2. Alternatively, a student may defer their registration and the entirety of their registration fee payment (**without penalty or administrative fees, at no additional cost**) to a future RD master class webinar taking place **in the next year** (from the start date of the webinar that was cancelled or rescheduled) to take that webinar. We are considering additional dates pending demand, but we can make no guarantees about the availability or dates of future offerings.
3. If a student is unable or unwilling to roll their registration fee to a different RD master class webinar within this 1-year grace period, we will issue a **100% refund** due to the inconvenience (if the webinar had to be rescheduled entirely) or a **partial refund** (pro-rated based on the days that the student attended before the interruption).

EQUUSOMA® Level 2 Practical Intensives

Student Cancellations

Students must attend the Level 2 in-person practical intensives in their entirety, as there is no way to cover the material by watching videos after the fact and no way to make-up the experiential time with equines outside of the practical intensives themselves. While live courses may be recorded, these recordings are not available at the present time. **Refunds are not possible** if a student must cancel/withdraw from a practical intensive, or if they miss more than 1 day of a practical intensive and must re-take the intensive. Reasonable accommodations may apply in cases of accessibility.

However, **a few options are possible on compassionate grounds**, such as deferring their registration fee to the next event held at that same location, along with a 25% surcharge (based on the paid registration fee) to assist with some of the expenses incurred due to holding a spot that cannot be filled with someone else. The original registration fee will be rolled over to the next possible offering of that particular event at that location, for a maximum of **1 additional year** past the date of day 1 of the event that had to be missed, to allow the student the opportunity to register again.

- If the student does not re-register for another offering within the following year at that same location, their registration fee will be retained and they must re-register at the full rate. At this time, they may choose to register at an entirely different location, or at the same one.
- If due to unforeseen circumstances, events cease being offered at that particular location within the 1-year grace period, the student will be able to roll their registration fee to the same event being offered at any other location within the 1-year grace period. If the student does not register at a different location within that time period, their registration fee will be retained and they must re-register at the full rate.

Instructor/Venue Cancellations

On occasion, a practical intensive may be affected by reasons beyond our control, such as due to faculty illness or emergency, travel advisories impacting the region where an intensive is being held, venue-related issues, and so on. In these cases, we may need to adjust some or all of the dates of an intensive. The revised dates may not work with a particular student's availability. If they are unable to attend the revised dates, **the following options are possible:**

1. A student may defer their registration and the entirety of their registration fee payment (**without penalty or administrative fees, at no additional cost**) to a future cohort taking place **in the next 2 years** (from the start date of the module that was cancelled, interrupted, or rescheduled) at the same location to re-take that practical intensive, even if they have already completed a portion of the practical intensive. Students who select this route must do so knowing that the Program Completion Policy still applies. We make no guarantees about the availability or dates of future cohorts.
2. If a student is unable or unwilling to roll their registration fee to a different cohort at the **same location** within this 2-year grace period to complete the rescheduled or interrupted practical intensive and proceed to the next one, we will issue a **100% refund** due to the inconvenience (if the practical intensive had to be rescheduled entirely) or a **partial refund** (pro-rated based on the days that the student attended before the interruption).

RD Master Class In-Person Seminar

Student Cancellations

Students are eligible for a **100% refund** if cancelling more than 90 days before the first day of the in-person seminar, and a **50% refund** if cancelling between 60-89 days before the first day of seminar. Online and In-Person Events

Overview

Video Recordings

EQUUSOMA® Level 1 online modules (lecture portions only) and the RD Master Class online webinar portion are always recorded, and recordings are accessible to students for a limited time. EQUUSOMA® Level 2 in-person practical intensives and the RD Master Class in-person seminar portion may also be recorded, but video access is not available at this time. Portions of recordings will be eventually included in our video library.

Video consent is required in order to take part in our events. We cannot guarantee that a particular student or their name will not show up in a recording in some way (either online or in person), or that a particular student can be edited out of video footage. Students who are not comfortable with the possibility of being recorded may opt out of registering for any event at this time. We generally film lectures and demonstrations, and do not film student practice rounds unless students are comfortable with it.

Online students may reduce the amount of time they are visible in a recording by muting their video and changing their screen name (after we have seen their actual name for attendance purposes). However, to track participation during EQUUSOMA® Level 1 online modules during the breakout rooms (which are not recorded), we require that students unmute their videos and are visible during these portions of the training.

Photography

We do not typically take screen shots during online events, so photography from online webinars is an unlikely occurrence. If this should occur (e.g., taking a gallery view photo), students have the option to mute their video so as to not be in the screen shot. Photography usually occurs at live events. Students who do not wish to be in photos may opt out of being photographed.

Social Media

The EQUUSOMA® team does not tag anyone on social media without prior consent, and the tagging we do usually only pertains to team members who have granted permission. We do not tag students, and leave that to each student to decide.
